Wood Veneer Ultimate Astragal Limited Lifetime Warranty

Overview

The Wood Veneer Ultimate Astragal offers many of the same features as the Ultimate Astragal. Endura Products' Astragals feature a flush bolt with patented floating bolt pads to seal against the inactive and active panels, as well as the sill. When the inactive door is unlocked, the seals lift up off of the threshold cap, stopping drag-induced damage to the seal, while reducing opening and closing force. The astragal also features four-way adjustable strike and deadbolt plates. These innovative features, combined with the thermally-broken, all-aluminum structural body, provides consistent long-lasting performance against air and water infiltration.



Ensuring Proper Performance:

To get the best possible performance from the Wood Veneer Ultimate Astragal, the following steps should be taken.

- 1. Assemble the Astragal to the door unit according to Endura's "Ultimate Astragal Pre-Hanger Installation Instructions".
- 2. Follow Endura's "Ultimate Astragal Field Installation Instructions" after installing the pre- hung door in the rough opening.
- 3. Wood Veneer Ultimate Astragals are shipped with a film applied to both the interior and exterior veneer faces to protect these surfaces during assembly. This film must be removed prior to finishing.
- 4. Since one side of the astragal will be exposed to the outdoors, an external grade finish coating is required. Apply an appropriate surface finish to the wood veneer according to the manufacturer's instructions upon installation. Ongoing maintenance of the finish coating is required to properly protect the wood. (Follow Endura's "Ultimate Veneer Astragal Finishing and Maintenance Instructions".)
- 5. If the door unit is installed without the final finish applied to the astragal wood veneer (the finish coating should be applied before installing the door unit), the wood veneer should be completely protected from weathering and moisture until the finish coat can be applied. The protective film should also be removed immediately to avoid exposure to direct sunlight and heat.
- 6. The surface of the wood veneer can be lightly sanded. Do not aggressively sand the veneer or the backing will show through.
- 7. To protect the integrity of the wood veneer and its bonding adhesive, do not expose the astragals to oils, thinners, solvent based cleaners or similar items.

If Endura Products, Inc.'s product that is the subject of Wood Veneer Limited Lifetime Warranty fails during the warranty period for reasons covered by Wood Veneer Limited Lifetime Warranty and the purchaser submits the written service request required under Wood Veneer Limited Lifetime Warranty, Endura Products, Inc. will:

REPLACE THE PRODUCT WITH A PRODUCT THAT IS AT LEAST FUNCTIONALLY EQUAL TO THE PRODUCT BEING REPLACED AND PROVIDE UP TO \$100 IN LABOR COSTS.

Extent of Wood Veneer Limited Lifetime Warranty

Wood Veneer Limited Lifetime Warranty does not cover damages due to external causes, including, but not limited to, improper handling, abuse, alteration, repair, lack of proper maintenance, or installation that is not in accordance with Endura's instructions. This warranty does not cover natural variations or fading in wood color due to improper finishing and maintenance or weathering.

Any use or care not in accordance with these instructions voids the Wood Veneer Limited Lifetime Warranty, and any damage caused by such use or care is not covered under this warranty.

The Wood Veneer Limited Lifetime Warranty is limited to the original purchaser and is not transferable.

Warranty Service

Endura Products, Inc. reserves the right to inspect first hand any claim for warranty service prior to remuneration, in order to verify that preparation installation and use of Endura's Wood Veneer Ultimate Astragal have been done in proper accordance with these requirements. Any tampering of the original astragal, or removal and/or replacement from the original location and installation will void this warranty.

To obtain warranty service, the purchaser must submit a written service request to Endura Products, Inc. at Endura Products, Inc. 8817 W. Market Street, Colfax, NC, 27235. A written service request must include: (1) proof of purchase, (2) a copy of Wood Veneer Ultimate Astragal Limited Lifetime Warranty, and (3) a written explanation of the problem.
